Voter pre-registration deadline and deadline to request a mailed absentee ballot is 5PM on October 20, 2025. Absentee voting is available at the Courthouse beginning October 15, 2025, from 8AM until 4:30PM Monday through Friday and will continue until Monday, November 3, 2025.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on Election Day and voters changing precincts, must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter of the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the County Auditor's office by Noon on Monday, November 10, 2025. Election Day Registrant attesters must provide an approved form of identification. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. PUBLIC TEST OF ELECTION EQUIPMENT:

The public testing of Hardin County's voter equipment to be used in the November 4, 2025 Combined City/School Election will commence at 9 AM on October 31, 2025 and continue daily until completed. The testing shall be completed no later than November 3, 2025. The testing is open to the public in the Courthouse Large Conference Room, 1215 Edgington Ave., Eldora, Iowa.
